To Whom it May Concern,

On Friday April 18th, 2025 Corell Electrical & Plumbing Contractors preformed a smoke test on all buildings of Covington Middle School. The purpose of this smoke test was to verify the integrity of the property's plumbing vent and sewer systems, and to ensure that all connections are sealed and functioning in accordance with local plumbing codes. A non-toxic smoke bomb was introduced into the schools plumbing system, smoke then circulated through the system to check for visible signs of leaks, improper venting, or illegal connections.

Observations & Findings:

- -Women's Restroom, 1st Floor: Smoke from bottom of toilet- Replace wax seal
- -Boiler Room, 1st Floor: Smoke from bus duct- No recommendations, smoke determined to be from Room 200 P-trap
- -Room 200, 2nd Floor: Smoke in room / originated from adjacent room- No recommendations, smoke pressure pushed through P-trap
- -Band Room, 1st Floor: Smoke in room / back smokes / originated from sink- No recommendations, smoke pressure pushed through P-trap
- -Boiler Room, 1st Floor: Smoke from floor drains- Filled dry floor drains with water & small amount of oil
- -Room 110, 1st Floor: Smoke in classroom / originated from sink- No recommendations, smoke pressure pushed through P-trap
- -Hallway, 1st Floor: Smoke in hallway- No recommendations, smoke determined to be from Room 110
- -Men's Dressing Room: Smoke from abandoned drain exposed in wall- Put cap on exposed drain
- -Men's Lockers Room: Smoke in room / originated from trap- No recommendations, smoke pressure pushed through P-trap
- -Girls Locker Room: Smoke in room / originated from sinks- No recommendations, smoke pressure pushed through P-trap
- -Kitchen: Smoke from abandoned drain pipe exposed in wall- Installed test plug in drain
- -Kitchen Bathroom: Smoke from bottom of toilet- Replaced wax seal

The plumbing smoke test was completed successfully. All signs of leakage, improper venting, or code violations that were detected during the inspection have been repaired up to standard code. All components of the system are functioning as intended and are compliant with applicable plumbing codes and standards.

Note on P-Trap Smoke Observation During Testing

During the course of the smoke test, a small amount of smoke was observed emitting from several fixture P-traps throughout the facility. This is a known and **normal occurrence** under certain conditions during smoke testing and does **not** indicate a plumbing failure or code violation.

P-traps are designed to hold water, which acts as a barrier to prevent sewer gases from entering occupied spaces. However, in rarely used fixtures (such as utility sinks, floor drains, or classroom hand sinks), the water in the trap can evaporate over time. When this occurs, the water seal may be temporarily lost, allowing smoke to pass through during testing.

All P-traps observed during this inspection were found to be:

- Installed correctly
- Up to current code standards
- Structurally sound with no cracks, leaks, or improper fittings

All plumbing systems at Covington Middle School are functioning properly and meet all relevant safety and code requirements. There are no hazards present to students, staff, or the surrounding community. The facility is safe for ongoing public use. There is no hazard to the public, students, or staff, and the system remains fully safe and compliant.

This statement reflects the completion of Phase B – Vent Stack Smoke Testing, conducted on April 18, 2025, following the successful completion of Phase A work performed under the original work order dated March 10, 2025.

Phase A involved the cleaning of 35 bathroom sink P-traps. Phase A included detaching, cleaning, and resetting the p traps as outlined in the initial proposal. Due to the age and condition of the existing plumbing fixtures, several metal P-traps were removed and replaced with new PVC P-traps at no additional cost.

Phase B consisted of comprehensive smoke vent testing on all roof vent pipes. Testing was completed using the smoke bomb method to evaluate the plumbing system for potential leaks. We have attached a report outlining any areas of concern that were noted during Phase B. All areas of concern have been corrected at this time.
